

HOE HERSTELLEN NA DWANG?

Internationale perspectieven op hoe patiënten herstellen van dwangervaringen binnen de geestelijke gezondheidszorg

Twee jaar lang deed het Europese onderzoeksnetwerk FOSTREN (https://fostren.eu/) onderzoek naar hoe dwang binnensluipt in de GGZ en naar wat professionals al dan niet doen om het gebruik van dwang in te perken. Op deze studiedag presenteren internationale experts het resultaat van deze zoektocht. Ze gaan met de deelnemers in dialoog over hoe het anders kan en bespreken hoe perspectieven vanuit onderzoek, hulpverlening en ervaringskennis gecombineerd kunnen worden. Alle lezingen zijn in het Engels, vragen kunnen in het Nederlands worden gesteld indien gewenst.

Prof. Sabine Hahn heads the School of Nursing and the Unit of Applied Research in Nursing at Bern University of Applied Sciences. She is the president of the Swiss Association for Nursing Science and visiting professor at Bournemouth University (UK). As project manager of national and international research projects her topics are violence, de-escalation and reduction of coercion in healthcare, staff retention as well as staff development in health care and quality development in nursing.

Prof. Dr. Stijn Vanheule is a clinical psychologist and professor of psychoanalysis and clinical psychology at Ghent University (Belgium), where he is the chair of the Department of Psychoanalysis and Clinical Consulting.

Prof. Dr. Lene Lauge Berring is a Ph.D. Associated professor, and research leader in University of Southern Denmark and Psychiatric Research Unit Region Zealand, Denmark. Her research focus is related to trauma informed care, violence prevention, de-escalation practices, safewards and all aspects of creating a healing and recovering environment in mental health.

Dr. Kevin McKenna is lecturer at Dundalk Institute of Technology. His work revolves around psychiatric and mental health nursing aggression and violence in health and social care. He focusses on the use of humanities in health education and has a special interest in clinical supervision.

Dr. Nutmeg Hallet is a Registered Mental Health Nurse and Lecturer in Nursing. Dr. Nutmeg teaches on a variety of under-graduate and post-graduate mental health nursing and research modules. Her specialist areas of teaching are de-escalation, coercion and trauma in mental health.

Prof. Dr. Evi Verbeke. Evi Verbeke is a psychologist and psychoanalyst who did a PhD on power and ethics in contemporary psychiatry. Currently, she works as a guest professor at the University of Ghent (Department of Psychoanalysis and Clinical Consulting).
